- If you already have an account, enter your email and password to access the platform.

2.3 Mark your tax deductible status

If you are a "Donataria autorizada" (authorized tax exempt organization) in Mexico and you want to appear as such on HIPGive:

- Make sure you are in "My organization" section on the menu to the left.
- Select the tab "Legal Information" and tick the "Authorized Donor" box.
- Select the tab "Files". You'll see that a box appears marked "Certificate of Fiscal Authorization from the SAT".
- Select the pencil icon (above) and then the plus sign in the box, to upload the document.

By certificate, we mean the letter that SAT has sent you confirming your status as an authorized tax exempt organization (Donataria autorizada) in Mexico.

 - A summary of the solution you offer and the value you generate for the people you serve.
 - A reason for people to get involved and an indication of what their donation can help you achieve, especially if given monthly.

3.4 Allow colleagues to access your page

We'll send all official notifications regarding your organization's page to the email of the person named as the owner of your profile and to the email address registered in the the "General Information" tab. Notification emails can also be sent to your colleagues if you choose to give them access as Administrators within HIPGive.

If you wish to give your colleagues access to edit your page:

- From the menu on the left, choose "Organizations" and then "Users."
- You will see a list of individuals who currently have access to edit your organizations' information.
 - To edit their contact information, select the pencil icon and make the changes.
 - To add a new colleague to your HIPGive team, select "Create user".

Even if you are not the target audience for your campaign, it is important for you to know how the process of donating to an organization on HIPGive works. This way, you can better guide your potential donors.

5.1 Choose the donation amount

- Select the currency in which you'd like to make your contribution.
- Enter the amount. You can choose from the four suggested amounts or enter your own.
- Decide how often you want to donate: monthly, quarterly, semiannual, or unique donation.
- Click the "Proceed to donation" button.

Currently, you can choose the amount you want to donate in US dollars (USD) or Mexican pesos (MXN), but donations can be made from any country in the world.



5.2 Share your details and choose your receipt

You will see a summary of your contribution and be asked to share your details:

- In addition to name, email and telephone number, you can leave a message to the organization.
- If you don't want the message to be published, select " Make my contribution anonymous" The organization will be able to see your name, message and contact details but no-one else will.
- If you wish to receive a tax-deductible receipt, tick the box "Do you need a tax-exempt receipt?".

5.3 Confirm your payment method

If you are making a <u>unique donation</u> to an organization with the status "donataria autorizada" (authorized tax-exempt organization) in Mexico, you will have the option to pay using these two additional methods:

- In-store donation at local convenience stores. Click the option and download the file where you will see a code that you must present at the counter to make the payment.
- Through SPEI (bank transfer in Mexico). Click the option and download the file where you will find the CLABE number to which you should transfer the funds.

5.4 Confirmation emails

After making a contribution on HIPGive, you will receive an email confirming the transaction to the email you provided at the time of donation.

- If your donation is recurring, you can check the donated amount, recurrence, and when the next charge will occur.
- If you made a one-time donation, only the donated amount will appear.

If you chose to receive a U.S. tax-exempt receipt:

• The confirmation email includes a statement that validates it as a fiscal receipt..

If you chose to receive a tax deductible receipt in Mexico (and entered your details at that time):

• Your receipt (CFDI) will arrive separately, in addition to the confirmation email.

> You may notice some transactions marked as "declined." This isn't due the platform; more often than not, it occurs because people do not enter their details correctly or the bank has put a block on the use of the card. We recommend that the person tries again or uses another payment method.



7. Transferring your funds

7. Transferring your funds

7.1 Timeline of monthly transfers

The payment process for recurring donations occurs on a monthly basis and takes between 2 to 3 weeks following the end of each month. This time allows for all transactions to be processed, including any clarifications that may have arisen.

7.2 Services and fees

Recurring giving campaigns have an administrative cost of 5% of the monthly transaction.

In addition, each contribution from your HIPGivers has a commission from the payment processors of 3.5% on average.

SERVICES AND FEES

Unlike many other crowdfunding platforms out there, HIPGive allows fundraisers to create and publish projects on HIPGive free of charge. As of December 2016 we got rid of our administrative fee, which means more of the funds go towards your project. The only fee that will be deducted from the total raised on the platform is a payment processor fee through an external provider.

Currently, the payment processor fee is determined pero payment processor. This is a flat rate and is not affected by whether or not you reach your project goal.

To avoid passing on any further costs and ensure organizations keep more of the funds they raise, we recently introduced the TIPHIP feature. When making a gift, donors are invited to contribute a small additional donation to cover HIPGive's operational expenses. This is entirely voluntary and well received by most donors.

7.3 Funds Transfer Process

The funds you raise through your organization's page will be sent via a bank transfer, based on the banking information you have provided on the platform, along with the documents.

When the payment is ready to be made, we will send an email confirming the amount of funds raised during the period, any additional funds if applicable, the deducted payment processor fee, the HIPGive fee, and the final transfer amount. To determine the total amount of funds, we use the following calculation:

Sum of contributions

- (Payment processor fees)
- (HIPGive fee)
- = TOTAL of the monthly transfer



For "donatarias autorizadas" in Mexico

 If your organization is a donataria autorizada, you will need to issue a tax-deductible CFDI for each amount disbursed monthly.

You will receive the fund transfer from HIP-Latinoamérica A.C. in Mexico. The CFDI must have the following information:

- Razón Social (Legal Name): HIP-LATINOAMERICA
- RFC: HIP160504288
- Address: Valladolid 50, Col Roma Norte, Cuauhtémoc, C.P. 06700 Ciudad de México

Additionally, you should consider the following details:

- · Payment Method: 03 Transferencia electrónica de fondos
- Payment: PUE
- Uso CFD (CFDI Use)I: G03 Gastos en general.
- Clave de unidad: M4 Valor monetario

Who can use HIPGive to coordinate a recurring giving campaign?

HIPGive is a platform for nonprofit organizations based in the United States or Latin America. Since we are also a nonprofit organization, we are required to ask participating organizations to verify that they are a legally established nonprofit and that the majority of the beneficiaries of the project are Latinx.

When creating your account on HIPGive, you will be asked to attach a document verifying your nonprofit status, typically the letter from the IRS confirming the 501(c)(3) status or, if you are an organization from Latin America, the articles of incorporation. We will also request the following documents and information:

- Financial statements from the previous fiscal year (or IRS 990 Form for US-based organizations)
- List of Board Members
- Budget for the current fiscal year
- Tax Identification Number
- Fiscal Sponsor Agreement (if applicable)
- Completed Legal Information tab on the platform
- Completed Bank Information tab on the platform

If you have opted to use the platform as a donataria autorizada in Mexico, you will also need to upload the following documents:

- Official letter as Donataria Autorizada from the SAT
- Power of attorney
- Official identification of legal representative
- Bank account statement (must match the account data registered in the "Bank information" section)



How much does it cost to set up a recurring giving campaign on HIPGive?

Creating your recurring giving profile on HIPGive is free. However, once you start receiving contributions, a transaction fee of 5% and a bank fee of approximately 3.5% will be applied. The bank fee may vary depending on the payment method, so you can check the full list of payment methods and fees <u>here</u>.

Which payment methods do you accept?

HIPGive accepts payments via credit card, debit card and PayPal.

If the organization is an authorized tax exempt organization in Mexico, you may also contribute via an electronic bank transfer (SPEI) or by downloading a code and making your payment in a convenience store.

Is HIPGive a secure site?

Yes. The system is tested manually and automatically every day to guarantee each and every operation is secure. The payment processors that we use are certified as Level 1 Service Providers within the Payment Card Industry Data Security Standard (PCI DSS) which requires an independent annual audit of their processes and systems.



Will I receive a tax deductible receipt for my contribution?

Yes, all donations can be tax deductible in the United States and, in some cases, in Mexico.

Immediately after completing a donation, you will receive an email confirming the transaction. If you opted to receive a tax deductible receipt as you made your contribution, this email will also serve as a tax deductible receipt in the US. Hispanics in Philanthropy is a 501(c)(3) non-profit organization with tax identification number 94-3040607. An exception to the above is when the organization to which you contributed is an authorized tax exempt organization in Mexico and is registered as such on the platform. In this case, if you chose to receive a valid tax deductible receipt in Mexico and included your fiscal information, you will receive another email with a Tax Receipt (CFDI) valid in Mexico.
